RECRUITMENT OF CIVILIAN PERSONNEL IN INDIAN NAVY – 2019
RESULT FOR RECRUITMENT OF BOAT CREW PERSONNEL

1. Refer to Advertisement published in the Employment News dated 14-20 Jul 18 DAVP 10702/11/0052/1819 for recruitment to the posts of Boat Crew Personnel.
2. The following candidates have been **provisionally selected for appointment** to the posts of Boat Crew Personnel at Visakhapatnam and Port Blair on basis of the written examination conducted on 26 - 28 Mar 19 and swimming test conducted on 02 Apr 19.
3. The appointment is provisional subject to the verification of Original certificates in support of essential qualification (Age, Education, Caste certificate, PwBDs, ESM etc, as applicable) as on the closing date of receipt of applications. The candidature of the candidates is purely provisional. It should be noted that merely calling candidates for verification of the documents / medicals does not in any way, entitle them for an employment / appointment in Naval Dockyard, Visakhapatnam.
4. The provisionally selected candidates will be sent call letters through post as per address mentioned in their application forms. The candidates are to report to the venue at the date and time indicated in the call letter for pre-recruitment formalities. 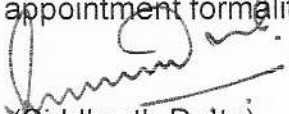
