- 2. It is further clarified that, the proposal to treat the subject veterans as pre-1996 retirees was analysed with due deliberation at the time of consideration of grant of ECHS membership to the subject ex-sailors. The eligibility for a pre 1996 retiree status for exemption of membership fee is only for veterans who are ESM and pensioners prior to 01 Jan 1996.
- Competent Authority ruled that they be categorised as Post 2003 Retiree Not a Member Yet (First Time Applicant) as they attained the twin criteria of eligibility of being ESM and pensioners only after the Hon'ble Supreme Court Judgment on 27 Sep 2018.
- 4. In view of the above, grant of ECHS membership to above category of veterans will be guided by following rules as on date:-
 - (a) They may apply under the category of (Ex-Serviceman Pensioner) Post 2003 Retiree Not a Member Yet (First Time Applicant) (No separate status/category of "Reservist" or "Special Pensioners" is under consideration).

- (b) One time contribution as applicable on the day of application will be paid by the above category of veterans.
