Para 4(c) & (d) of our letter dated 17 Sep 2018:

- (c) In case desired treatment is not available in the station of parent PC, patient can choose any city within the RC where the treatment is available. TA will be, however, allowed only if it happens to be the closest station from the parent pc city.
- (d) Patient can choose any city (any emp hosp in the country) for treatment. While treatment is allowed but TA will be allowed if the selected facility is not available any city of RC.

READ

Other city referrals and corresponding travelling allowances will be applicable only to the nearest Service/Private empanelled hospital where such medical treatment facility is available and not as per choice of the patient. Same is to be determined by service /ECHS medical doctor and authenticated by the OIC ECHS Polyclinic prior to resorting for such outstation referrals.
